This block of time will be set aside for the rental of fountain, and will be held until balance is received. At the time of full payment, the client will be inked in as a permanent date.

Provision: Chocolate Perfection/Sweet Endings will require access to the desired set up area approx 1 hour prior to event start time, and 1 hour at the conclusion of event for setup and break down. The client is responsible for providing a sturdy, skirted table for the chocolate fountain and a 120-volt circuit (that adheres to contemporary safety standards and supplies us with at least 15 amps), within close proximity of the fountain set up. Client accepts full responsibility and is liable for any damages injuries or delays that may occur as a result of failure to comply with these provisions. DIPPERS MAY BE PROVIDED BY CPSE OR A CATERER. Whoever provides dippers will also be responsible for providing plates, napkins and serving dishes. **NO OUTDOOR EVENTS!**

Cancellation: No cancellations, except in writing by either party (Client or Chocolate Perfection/Sweet Endings). Deposit will be forfeited if cancellation is initiated by Client. Liability of Chocolate Perfection/Sweet Endings to perform said services is subject to proven detention due to illness, accidents, or any other actions not under its control.

Liability: This agreement and the contents hereof represents the only warranties, express or implied, between the parties, including any implied warranty or fitness for the particular purpose and for any other obligation or liability on the part of Chocolate Perfection/Sweet Endings. Chocolate Perfection/Sweet Endings shall not be liable for an injury, loss or damage directly or consequently arising out of the use or inability to use Chocolate Perfection/Sweet Endings, whether used singularly or in conjunction with any other equipment. Client will indemnify Chocolate Perfection/ Sweet Endings against, and hold Chocolate Perfection/Sweet Endings harmless from all claims, actions, proceedings, costs, damages, and liabilities, including attorney fees, arising out of, connected with, or resulting from the use of Chocolate Perfection/Sweet Endings.

The fee for rental of fountain for up to 3 hours (excluding set up and break down time) is \$399, plus applicable sales tax --\$32.92 (8.25%). For each additional hour please add \$45 plus tax. For each 100 guests over 400 please add \$45 plus tax. (Prices subject to change). A signed copy of this agreement will be sent to client upon receipt of deposit.
